


#### 3. OBJECTIVES

- 4.3 The Association shall not work in any manner which may be prejudicial to the interests of PARENTS PRIDE PUBLIC SCHOOL and the members of the Association.

## 5. MEMBERSHIP

- 5.1 Both parents are eligible for membership of the Association. However, authorized representatives of parents can act as guardian of students.
- 5.2 If a child does not have any living parent, then the guardian as per provision of law under The Constitution of India shall be eligible to be a member of the Association.
- 5.3 All teachers shall be associate members of the Association.
- 5.4 The Association shall maintain a Register of Members with all such particulars as may be deemed necessary.


## 6. MANAGEMENT


- 6.1 The Management of the Association shall be vested in the Executive Committee as per the composition as laid down in *section 13*.
- 6.2 The Executive Committee shall be responsible for day to day management, execution and working of the Association and will have necessary authority for taking all appropriate action for carrying out, executing and implementing the resolutions and directives passed and conveyed by General Body of Parent – Teacher
- 6.3 The quorum for an Executive Committee meeting shall be 1/3rd of the members from parents as well as teachers separately.

## 7. AUTHORITY AND FUNCTIONS OF EXECUTIVE COMMITTEE:

Subject to the general control by the General Body of the Association, the Central Executive Committee will have the following functions and authority besides those that may be incidentally vested in it:

- 7.1 To admit members.
- 7.2 To frame rules and regulations subject to this constitution for the proper functioning of the Association.
- 7.3 To call meetings of the General Body as and when it deems fit or it is necessary by virtue of the provisions of the Constitution.
- 7.4 To do all acts and take such actions as may be necessary in furtherance of the aims, objectives and activities of the Association.
- 7.5 To submit the Annual Report on the working of the Association at the Annual General Meeting.
